We recognize the importance of protecting our natural environment as we innovate to transform healthcare, and this policy outlines our commitment to sustainability and environmental stewardship, intended for our employees, partners, clients, and the global community.

## **Our Commitment**

- Sustainable Practices: We pledge to continuously improve our environmental performance to adopt sustainable practices. This includes measurement of carbon emissions, strategies on electronic waste reduction, energy conservation, and carbon footprint minimization through remote working technologies and energy-efficient office spaces.
- 2. Progressing towards Carbon Reduction: In support of a healthier world and striving to decrease our impact on the climate, we commit to quantifiable decreases in our carbon emissions. We are proud to share that as part of this commitment, we have received approval from the Science Based Targets initiative (SBTi) on our near-term targets, a huge milestone in our ESG journey. Our targets include a 42% reduction in absolute scope 1 GHG emissions by 2030, an increase in active annual sourcing of renewable electricity from 0% in 2023 to 100% in 2030, and a 25% reduction in absolute Scope 3 GHG emissions from purchased goods, services, capital goods, and business travel by 2030. We commit to progressing towards these goals and engaging our stakeholders in our carbon reduction journey.
- 3. **Compliance and Beyond**: Real Chemistry will comply with all applicable environmental laws, regulations, and standards. We aim to not just meet, but exceed these requirements wherever possible with the adoption of stricter internal standards to protect the environment.
- 4. **Resource Management**: We are dedicated to the efficient use of resources, particularly in our digital and physical operations. Our goal is to minimize use of non-renewable resources and maximize use of renewable resources, including sustainable digital infrastructure.
